- Your electronic or physical signature

Upon receipt of a valid notice, Plucasa may remove or disable access to the content, notify the uploader, request additional information, or restrict repeat infringers. Response times may vary depending on complexity.

- Name and contact information
- URL of the removed material
- Statement under penalty of perjury that removal was a mistake or authorized
- Electronic or physical signature
